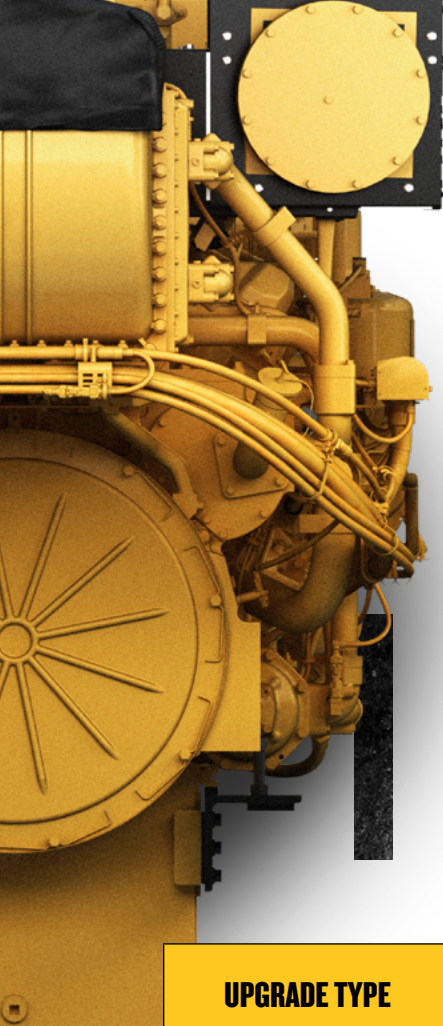




EMISSION UPGRADES

WHAT IS MY EPA STATUS FOLLOWING AN UPGRADE?

The United States Environmental Protection Agency (US EPA) allows OEM-provided EPA-compliant service options via certified, verified, or rebuilt configurations.

*Per the EPA's Marine Remanufacture Program, vessel owners must use an EPA-certified remanufacture system at the time of upgrade, if available.

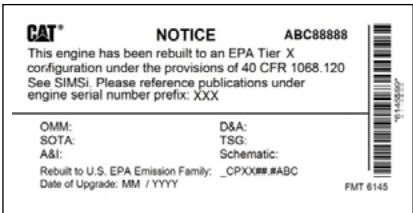

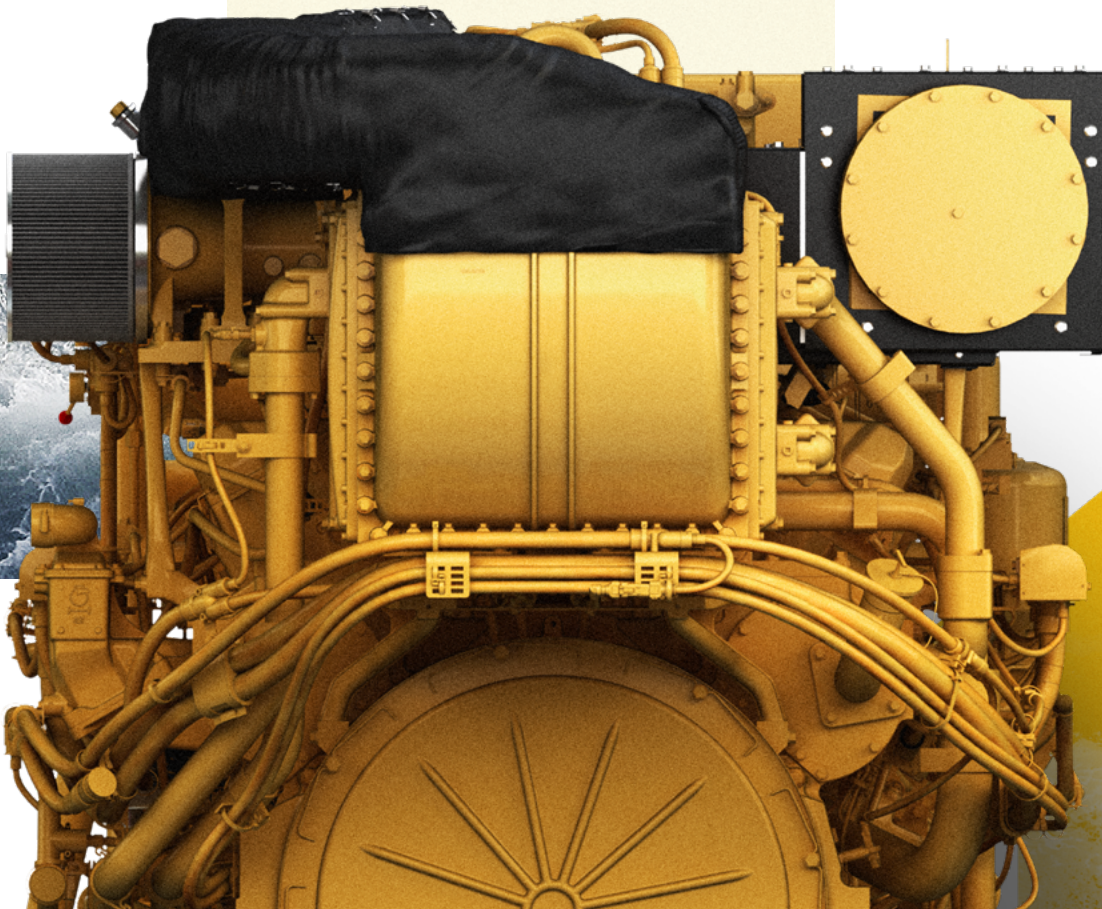
